# SUMMARY

I have worked since January 2010 as a Consultant Cardiothoracic Surgeon at King's College Hospital, London with a mixed practice of adult cardiac and thoracic surgery.

I trained in Cardiothoracic Surgery on the London South East Thames Training Program and in Halifax, Canada. I have received the Certificate of Completion of Training and I am on the General Medical Council Specialist Register for Cardiothoracic Surgery.

I am fully trained in both Adult Cardiac and Thoracic Surgery. I have a particular interest in Video Assisted Thoracoscopic Surgery (VATS) and trauma surgery.

As well as providing a high class clinical service, I enjoy and am fully committed to training and teaching undergraduates and postgraduate surgical trainees. I am involved in the formal appraisal of the clinical competencies of surgical trainees and use the tools of the Intercollegiate Surgical Curriculum Project as a Clinical Supervisor and Assigned Educational Supervisor.

My established areas of research interest include neuropsychological protection during cardiac surgery and cardiothoracic trauma management.

Since the beginning of 2015 I have developed a medico-legal practice which is steadily increasing. I have written expert witness reports, compliant with Part 35 of the Civil Procedure Rules, in clinical negligence and personal injury cases since 2015. Currently I am able to complete 20-25 full reports per year as well as screening reports if required. Turnaround time for reports is 2 weeks.
