- 1.I am a full-time NHS Consultant in Orthopaedics and Trauma Surgery since 1993.
- 2.I am an honorary clinical senior lecturer in Orthopaedics and Trauma Surgery.
- 3.I qualified as a doctor with a Medical degree (M.B., B.Ch.) in 1980, after which I completed a Master's degree in Orthopaedics M.Sc. (Orth) in 1986. I have been a Fellow of the Royal College of Surgeons (FRCS) since 1989, and I hold a Diploma in Biomechanics (1996).
- 4.I have the Cardiff University Bond Solon Expert Witness Certificate.
- 5.I am registered with ico; all work is GDPR compliant.
- 6.I am on different expert witness websites and directories.
- 7.I am currently on different medical expert databases and the expert witness panel of many solicitors and medicolegal reporting firms.
